## RELEASE AND INDEMNITY

In consideration of receiving or continuing a membership in the [Deas Island Yacht Club](#) (the Club) and thereby being permitted to enter a member's vessel in any Club event, each of the undersigned agrees to be bound by the Club rules as set out by the Board of Directors, except where such rules are in conflict with the Release and Indemnity, in which case the Release and Indemnity shall govern.

Yachts participating in Club events do so at their own risk, and each of the undersigned specifically agrees to indemnify and hold harmless the Club, event organizers, and the Club Executive, its organizers, and its agents, officials, servants, and representatives from and against all claims, actions, costs, expenses, and demands in respect to death, injury, loss or damage to person or property howsoever caused, arising out of or in connection with a skipper or his or her crew taking part in any event, notwithstanding that the same may have been contributed to or caused or occasioned by the negligence of the same bodies or any of them, or their agents, officials, servants or representatives.

This Release and Indemnity shall be a continuing release and indemnity with the intention that it be effective as long as each of the undersigned is a member of the Club and shall be binding upon the heirs, executors, administrators and assigns of each of the undersigned.
